

Arlington Township
Regular Meeting Minutes
March 20, 2013

The meeting was called to order at 7:30 p.m. by Supervisor Jacque Phillippe. Board members present were Pitts, Pugsley, Bregger, and DeLeo.

The minutes of the February 20, 2013 were read. Motion by Pitts supported by DeLeo to approve the minutes. Motion Carried.

Police Report-- There were (35) calls in the township

Fire Report-- There were (48) calls with (6) in the township. A circus is coming to town the weekend before school starts in the fall. The ABB Annual Meeting will be held on 3-27-2013 at 7:00 p.m. A Hand's only CPR training class will be held on 3-28-2013 at 6:00 p.m. A donation for \$2000.00 has been received for new CPR mannequins .

Supervisor's Report-- The Board of Review went well. The website quote received from Hindsite Interactive was for 450.00 to 675.00 dollars with 10 to 22 dollars to manage the site monthly. Jacque will be meeting with another contractor soon. Motion by DeLeo supported by Pugsley to pay up to \$200.00 to hire a website contractor. Motion Carried.

Clerk Report-- The County Clerk conducted a post election audit of the township's November election documents. We passed with flying colors. There will be a Lawrence School Election in May.

Planning Commission Report-- The commission will meet April 3, 2013 to review special use permits, conduct a hearing on the new zoning book, and discuss the Ridgeway Market project.

Hospital Report -- (2) new PA physicians will be working in Urgent Care opening in May. Hours will be 11 am to 9 pm 7 days a week.

Commissioner's Report-- there is a new County Website. We should contact Ted Thar to receive the password.

Treasurer's Report-- Phil presented a proposed 2012-2014 budget in the amount of \$209,250.00. Also a road budget of \$148,656.00 was proposed. Motion by Pitts supported by DeLeo to adopt these budgets. Motion carried by a unanimous roll-call vote. Motion by DeLeo supported by Bregger to pay the bills. Motion Carried Motion by Pitts supported by Bregger to pay up to \$220.00 in early April if necessary. Motion Carried.

New Business-- Motion by DeLeo supported by Bregger to use SW Michigan Dust control this year for road salting. Motion carried.
