Regular Meeting Minutes
October 18, 2017

The meeting was called to order at 7:00 p.m. by Supervisor, Jacque Phillippe. Board members present were Pitts, Pugsley, DeLeo and Melvin.

Motion by Pitts supported by DeLeo to approve the September minutes with spelling corrections.
Motion Carried.

Police Report—No written report.

Fire Report— Bangor— there were (26) calls with 3 in the Township.

Public Comment— a township resident had questions about the placement of fence post on the boundary lines at the township receiving station.

Road Commission—the Road Commission has terminated its current operations superintendents and will be hiring a new operations manager. Several positions are also currently unfilled.

County Commissioners Report—Palisades Power Plant will remain open until 2022. A grant has been received to hire a new Veteran Counselor.

Seniors Report—Report could not be located to include in the minutes.

Planning Commission Report—none

Enforcement Report—Brian Knotek, township attorney, provided a letter report in his absence. David Letten court proceedings have been delayed again. Brian will negotiate with Letten's Attorney to try and get a resolution to the matter by the first of November. The Judge has given the township the go-ahead to clean the Burkhardt property and place the cost on the tax roll for the parcel. Bids will be received which will be reviewed at the November Board meeting. The 425 Rescission will result in the tax parcels being put back into Arlington Township's Roll. Brian is also preparing a Township Policy to be included in our Ordinances detailing the Official duties of township inspectors and ordinance officials concerning entering property owners property.

Clerk Report—It has been suggested by the contractor, Field Plumbing & Heating, that our new furnace and boiler system be given an annual inspection. Motion by Pitts supported by Melvin to authorize the inspection on a not-to-exceed basis of \$250.00. All members voted in the affirmative. Motion Carried.

Supervisor Report—A bid to replace the roof has been received from Lakefront Roofing in the amount of \$9,987.38. Motion by Pitts supported by Melvin to accept the bid. All members voted yes. The motion

was carried. A bid from Building Restorations to repaint the hall in the amount \$9,431.00 was accepted previously. The contract has been signed. The projects will be done as soon as possible, weather permitting.

Treasurers Report— Phil Pitts presented the monthly bills for payment. Motion by Melvin to pay bills seconded by Pitts. A roll call vote followed. All voted “YES” none voted “NO”
