SPECIAL MEETING
VIRTUAL VIA ZOOM VIDEO CONFERENCING DUE TO COVID 19 RESTRICTIONS
FEBRUARY 23, 2021**

All voting done by roll call vote

Derek Babcock (Chair) called the meeting to order at 6:02 pm

Donna made a motion with support from Joe:

To review, clarify and approve the minutes from the February 3, 2021 PC meeting.

Minutes of the February 3, 2012 meeting of the Planning Commission were reviewed and clarified. Regarding 26980 CR 215 (DragonFly) application for expanded use and revised site plan. Brian explained that there are 2 motions to consider, 1 being the Site Plan and the 2nd being addition to the minutes. He explained the question is if the Commissioner's intent was to recommend to the Board the approval of the Site Plan along with the recommended approval of the 10 additional licenses. Derek said they had been one and the same. Georgette asked if we were discussing a Site Plan on property they don't own. Brian explained they needed ownership or an okay from the owner and if the Township approves, they would go ahead with the sale that they currently have a Purchase Agreement on. Georgette said it was her opinion that we cannot do this under the moratorium. Derek said we didn't talk about the moratorium. Tina asked about expanded use and Brian responded that the term expanded refers only to the number of licenses. Derek said we are voting on a new Site Plan and we have already recommended approval of additional licenses.

To add to the motion of February 3, 2012 recommending approval of the 10 additional licenses, to recommend approval to the Board the new Site Plan for 26980 CR 215 (DragonFly).
