AN ORDINANCE AMENDING ARTICLE II, SECTION E OF ORDINANCE 2021-09

THE TOWNSHIP OF ARLINGTON ORDAINS:

Article II, Section E of Ordinance 2021-09 is hereby repealed and replaced with the following, which shall be effective 30 days after publication:

E. Hours of Operation, Lighting, and Generators.

Generators shall not be used at any marijuana business except in emergencies. Outdoor artificial lighting shall be limited to security lighting that is approved by the Township. Beginning with sunset and continuing until sunrise, as established by the National Weather Service, greenhouses or similar structures that do not totally block light from the outside in which artificial lighting is used shall be covered with cloth or a comparable material in order to reduce and diffuse lighting. The Township shall have the right to approve the material used for this purpose. Outdoor activity at marijuana businesses shall not be conducted between the hours of 10:00 p.m. and 6:00 a.m. Marijuana retail and provisioning centers shall not be open to the public between the hours of 8:00 p.m. and 10:00 a.m.
