Arlington Tax Assessor: Danielle, reported on the July Board of Review. She is updating assessment records.

Zoning: She has also received a couple of questions and inquiries on potential new businesses.

Senior Services: De Leo, reported on new building and services being reinstated that were available prior to Covid. The outreach activities are coming back with the help of volunteers.
