PUBLIC COMMENTS ON THE AGENDA ITEM- OUTDOOR WOOD BURNING BOILER

•

Public comments focused on the sole agenda item, the proposed Outdoor Wood Burning Boiler Ordinance. Discussion followed.

Discussion comments and suggestions included:

- Burning materials as per manufacturer recommendations.
- Focus the Ordinance on the areas or districts where there is a problem, namely residential areas.
- Exterior boilers should not be permitted in residential, more populated areas-define plated and subdivisions.
- If the main goal is abating nuisance and improving air quality-why not improve the current nuisance ordinance to include air quality? And address other open burning?
- Instead of monitoring specific "burning" why not have an air quality standard for the township, perhaps based on EPA standards?
- Can particles in the air be accurately measured? Yes, then the township should invest in these instruments to be objective based on real data and not subjective.
- Setbacks were OK and mainly applied to residential areas.

- Seasoned wood should be burned and is common knowledge.
- Stack height to better dissipate smoke and diminish nuisance was discussed. This most applied to residential areas. The pros and cons of exterior insulated stacks was discussed.
- Issues with wood boilers could be handled with nuisance complaints, the requirements for existing wood boilers in residential areas outlined in the Ordinance gave direction on abating some nuisance issues.

Public comments were then closed.

BOARD DISCUSSION was opened and specific comments for clarification were asked. Board Discussion was closed.
