ORDINANCE FOR REGULATION OF OUTDOOR WOOD-BURNING BOILER

The purpose of this ordinance is to promote, and to safeguard the health, comfort, living conditions, safety, and welfare of the citizens of Arlington township by regulating the air pollution of outdoor wood furnaces.

1. **DEFINITIONS**

- a. "Nuisance": As defined in Section 10.02, Definitions, Arlington Township Zoning Ordinances.
- b. "Outdoor Wood Boiler": Also known as an outdoor wood-fired boiler, outdoor wood-burning appliance, or hydronic heater, means a fuel-burning device that is designed to burn clean wood or other approved solid fuels and is not located within a building intended for habitation by humans or domestic animals; and heats building space and/or water through the distribution, typically through pipes, of a fluid heated in the device, typically water or a mixture of water and antifreeze.
- c. The terms "platted", and "Subdivision" shall have the definitions found at MCL560.102.

2. REQUIREMENTS

- a. Existing outdoor wood boilers in platted areas or subdivisions at the time of adoption of this ordinance <u>must comply</u> with:
 - i. Chimney must be of double wall insulated construction.
 - ii. The Chimney stack termination shall be a minimum of 15 feet above immediate grade. The chimney stack should be 2' above the roof line of the nearest habitable structures located on adjacent properties and such structures are within 150'of the neighboring outdoor wood boiler.
- b. An outdoor wood boiler shall be in compliance with local fire codes

| e. Existing wood burning boilers in non-platted areas/subdivisions (area defined) at the time of adoption of this ordinance may continue to operate but cannot be replaced or relocated without compliance with this ordinance. | | | | |
| f. Only seasoned dry, and untreated wood and clean burning wood byproducts (such as wood pellets) should be used for fuel. Other biomass fuel materials may be used (such as corn, corn cobs, cherry pits) provided that the unit is designed to burn such materials while meeting the emissions requirements stated in this section. Any items not allowed by the manufacturer are prohibited. | | | | |
| g. The outdoor wood furnace must be operated according to the manufacturer's instructions as well as all applicable township, county, state, or federal requirements. | | | | |
| h. Emission Standards: All outdoor wood furnaces installed after the effective date of this ordinance shall comply with the Phase 2 emissions guidelines of the United States Environmental Protection Agency's (USEPA) Voluntary Program for Hydronic Heaters. Should the USEPA, the State of Michigan or Van Buren County adopt more restrictive requirements, all wood boilers installed after the effective date of the new requirements shall comply with the more restrictive requirements. | | | | |
