

The Arlington Township Treasurer is available in person at the Arlington Township Hall (52022 34th Avenue, Bangor, MI) 9:00 am until 5:00 pm on **September 15th, December 30th and March 2nd** to collect **2025 Summer and Winter** taxes.

Tax payments may be dropped in the black drop box near the main entrance to Arlington Township Hall. Any payments dropped after 5:00 pm on **September 15th, March 2nd, or the end of the month** will be considered received the following business day. If paying in cash, we prefer you pay in person. To pay in person, please schedule an appointment by leaving a message for the Treasurer at 269-427-7300 (#3). **We prefer checks, but also accept money orders, cashier's checks or cash. If paying in cash, you must have the exact amount; no change will be made. When paying by check please make sure the number and text amount match, and match the tax bill. We DO NOT accept credit or debit cards.**

Summer taxes that are not postmarked by **September 15th**; OR paid in person or dropped in the black Drop Box by 5:00 pm on **September 15th** are considered late, and incur a 1% interest charge through September 30th, and an additional 1% at the 1st day of each month until **February 28th**.

Summer taxes may be deferred until **March 2nd** if your property is either [1. AG land] OR [2. your principal residence with your gross household income less than \$40,000 last year AND you are 62 years or older, disabled or Eligible Serviceperson, Veteran, Eligible Widow or Widower]. You must apply for deferment at Treasurer's office by **Sept 15th**. Winter tax payments become delinquent **March 3rd**.

Beginning **March 3rd**, you must submit unpaid Summer and Winter tax payments to the Van Buren County Treasurer (269-657-8228; 219 E. Paw Paw Street, Suite 101, Paw Paw, MI 49079).

The due date of Winter taxes can be deferred until **April 30th 2026** without interest, if this your principal residence AND [you are at least 62 or disabled and have applied for and not yet received the MI property tax credit before Feb 15th]. A copy of the income tax form must accompany your application for deferral. A copy of the form can be obtained at the Township Hall or online at

March 2nd is the last day to submit your current year **(2025)** Summer and Winter tax payments to Arlington Township.

You can change your anticipated payment date in order to recalculate amounts due as of the specified date for this property.

Enter a Payment Date

Please note the changes to the USPS postmark rules and the potential effect on processing property taxes, ballots and other form deadlines.

For property taxes you can drop off in person or place in the black metal box to the right of the front doors of the Arlington Township Offices. The treasurer will honor a March 2, 2026 postmark. A postmark on or after March 3, 2026 will be delinquent and will need to be paid through the Van Buren County Treasurers office.

The USPS changed postmark rules in late 2025, meaning the date stamped on mail now reflects when it's first processed at a regional facility, not when you dropped it off, creating potential delays of a day or more for tax forms, ballots, and other deadlines. To ensure your mail is postmarked on the date you mail it, take it inside a post office and request a manual postmark, use [Certified Mail](#), or mail time-sensitive items several days before the deadline.

Key Changes Explained

- **Processing Date:** The postmark reflects the date of the first automated sorting operation at a regional hub, **not the drop-off date**.
- **Delays:** Mail might sit at a local post office before being sent to a regional center, delaying the postmark date.
- **Impact:** This affects "timely mailed" deadlines for taxes (IRS), legal documents, and mail-in ballots, potentially making them late.

How to Ensure Your Mail's Date

- **Go Inside:** Take your item to the counter and ask for a manual postmark on the date you mail it.
- **Use Certified/Registered Mail:** These services provide proof of mailing on the date of acceptance.
- **Mail Early:** Send time-sensitive items several days before the deadline to account for processing delays.

Why This Happened

- These changes are part of the USPS's "Delivering for America" plan to streamline operations and cut costs by consolidating processing centers.

Per the Van Buren County Treasurer: Impact on the Delinquent Tax Collection of 2025 Taxes

March 2 and Prior Postmark: My office will honor postmarks per MCL 211.44b.

Missing Postmark: Will be processed as a delinquent payment with interest and administration fees applied. Taxpayer must provide certified mail receipt as proof if disputing delinquent fees.

March 3 and Later Postmark: Delinquent interest and fees apply. There is no remedy to remove or appeal.
